Question:

To preserve public safety and ensure essential fire protection and emergency medical response is provided to our community by funding existing service levels and improving response times by operating a second fire station shall the Oakdale Fire Protection District Ordinance No. 2019-01 be adopted, authorizing the District to levy a special tax, including \$380 plus \$0.07 per square foot per residential unit, raising approximately \$3,935,000 annually until repealed, with annual audits, and all money staying local?


