<p><b>July 1 – July 15</b>  <b>(E-127 to E-113)</b></p>	<p><b>Municipal Notice of Election Publication</b>          For cities consolidating with this election, the city clerk shall publish a Notice of Election between these dates. The notice shall contain the date of the election, polling hours, any offices to be filled and/or measures to be voted on, the qualifications required for each office, location where declaration of candidacy forms will be available, where the forms are to be filed and the deadline for filing forms.  <i>EC 12101, 12102</i></p>
<p><b>July 3</b>  <b>(E-125)</b></p>	<p><b>District Office Confirmation and Boundary Lines Form</b>          Districts consolidating with this election must complete and return the District Confirmation of Offices and Boundary Lines form by E-125.  <i>EC 10509</i></p>
<p><b>July 5</b>  <b>(E-123)</b></p>	<p><b>Specifications of the Election Order</b>          School boards shall deliver this document to the County Superintendent of Schools and the county elections official.  <i>ED Code 5322</i></p>
<p><b>July 8 – August 7</b>  <b>(E-120 to E-90)</b></p>	<p><b>County Notice of Election Publication</b>          The county elections official shall publish a Notice of Election between these dates. The notice shall contain the date of the general district election, name of the offices for which candidates may file, state the qualifications required for each office, location where declaration of candidacy forms will be available, where the forms are to be filed and the deadline for filing these forms.  <i>EC 12112</i></p>
<p><b>July 14</b>  <b>(E-114)</b></p>	<p><b>Municipal Calling of Special Election to Fill Vacancy</b>          Last date for a city council to call a special election to fill a vacancy on the next regularly established election date, to be held not less than 114 days from the call of the election. If the election is not called by this date, the vacancy cannot go to election on this established election date.  <i>GC 36512 (b)</i></p>

<p><b>July 15 – August 9</b>  <b>5:00 p.m.</b>  <b>(E-113 to E-88)</b></p>	<p><b>Candidate Nomination Period</b>  All candidates, including incumbents seeking re-election to the same office, must file nomination documents with the elections official during this period. <i>EC 10220, 10510, 13307</i></p> <p><b>Optional Candidate Statement of Qualifications Submittal Deadline</b>  All candidates who opt to include a Candidate Statement of Qualifications in the Stanislaus County Voter Information Guide must submit their statement and pay the required deposit prior to the close of the nomination period. Once filed, statements may not be changed but may be withdrawn up until 5:00 p.m. of the next business day after the close of the nomination period. <i>EC 13307-13308</i></p> <p><b>Form 700 Candidate Statement of Economic Interest</b>  Candidates running for office must file FPPC Form 700 prior to the close of the nomination period. <i>Municipal Advisory Council candidates are exempt. GC 87100-87314</i></p>
<p><b>July 31</b>  <b>(E-97)</b></p>	<p><b>FPPC Semi-Annual Campaign Statement Due</b>  For period covering 1/1/19 – 6/30/19. <i>GC 84200, 84218</i></p>
<p><b>August 7 – November 5</b>  <b>(E-90 to E)</b></p>	<p><b>FPPC Late Contributions and Independent Expenditures of \$1000 or More</b>  Within 24 hours of the transaction, FPPC Form 462, Form 496 or Form 497 must be filed with the appropriate filing officer <i>GC 82036, 82036.5, 84200.6</i></p>
<p><b>August 9</b>  <b>5:00 p.m.</b>  <b>(E-88)</b></p>	<p><b>Close of Candidate Nomination Period</b>  Candidate nomination documents are due. Incumbents who wish to file as a candidate for their own office <i>must</i> file by this date. Last day to withdraw declaration of candidacy papers except when there is an extension to that office. FPPC Statements of Economic Interest Form 700 are due. <i>EC 8020, 10407; GC 87201</i></p>
<p><b>August 10 – August 19</b>  <b>(E-87 to E-78)</b></p>	<p><b>10-Day Public Examination Period For Statement of Qualifications</b>  (for offices in which candidate filing closed on August 9)  During this period any voter of the jurisdiction or the county elections official may seek a writ of mandate or an injunction requiring any or all of the materials to be amended or deleted. The writ of mandate or injunction must be filed no later than the end of this period. <i>EC 13313</i></p>
<p><b>August 10 – August 14</b>  <b>5:00 p.m.</b>  <b>(E-87 to E-83)</b></p>	<p><b>Extension of Candidate Nomination Period</b>  Extension period for candidates other than the incumbent <i>if</i> the incumbent did not file by E-88. This provision does not apply if there is no eligible incumbent to be re-elected. <i>EC 10225, 10407, 10516, 10604</i></p>
<p><b>August 15 – August 24</b>  <b>(E-82 to E-73)</b></p>	<p><b>10-Day Public Examination Period For Statement of Qualifications</b>  (for offices in which candidate filing closed on August 14)  During this period any voter of the jurisdiction or the county elections official may seek a writ of mandate or an injunction requiring any or all of the materials to be amended or deleted. The writ of mandate or injunction must be filed no later than the end of this period. <i>EC 13313</i></p>
<p><b>August 15</b>  <b>11:00 a.m.</b>  <b>(E-82)</b></p>	<p><b>Randomized Alphabet Drawing</b>  Conducted by the Secretary of State to determine candidate name order as it will appear on the ballot. <i>EC 13112</i></p>
<p><b>September 6</b>  <b>(E-60)</b></p>	<p><b>Special Vote By Mail Ballot Requests</b>  First day the county elections official may process applications for special Vote by Mail ballot requests (Military and Overseas voters). <i>EC 300, 3105</i></p>
<p><b>September 9 – October 22</b>  <b>(E-57 to E-14)</b></p>	<p><b>Write-In Candidacy</b>  Statement of Write-in Candidacy must be filed with the county elections official to be a qualified write-in candidate for offices appearing on the ballot. <i>EC 8600-8606</i></p>

<b>September 26 – October 15 (E-40 to E-21)</b>	<b>County Voter Information Guides</b> Voter Information Guides are mailed to each registered voter during this time. <i>EC 13303</i>
<b>September 26 (E-40)</b>	<b>1<sup>st</sup> FPPC Pre-Election Campaign Statement Due</b> For the period covering 7/1/19 – 9/23/19. <i>GC 84200.8(a)</i>
<b>October 7 – October 29 (E-29 to E-7)</b>	<b>Regular Vote by Mail Ballot</b> Mailing and processing period for Vote by Mail ballots. Ballots will be available at the county elections office. <i>EC 15101</i>
<b>October 21 (E-15)</b>	<b>15-Day Close of Registration</b> Last day to register for this election. Postmarks, DMV, online registration and personal delivery to the elections office are acceptable.
<b>October 22 – November 5 (E-14 to E)</b>	<b>Conditional Registration Period</b> Eligible persons who missed the 15 day close of registration may appear <u>in person</u> at the county election official's office and register to vote provisionally for this election. <i>EC 2170</i>
<b>October 24 (E-12)</b>	<b>2<sup>nd</sup> FPPC Pre-Election Campaign Statement Due</b> For the period covering 9/24/19 – 10/21/19. <i>GC 84200.8(b)</i>
<b>October 29 (E-7)</b>	<b>Municipal Publication</b> Not later than one week before the election, the city clerk shall publish a list of the nominees and the respective offices for which they have been nominated. If applicable, this publication shall also include a synopsis of any measure that will appear on the ballot. <i>EC 12110, 12111</i>
<b>October 30 – November 5 (E-6 to E)</b>	<b>Special 7-Day Ballots Available</b> Available at the county elections office for those voters unable to vote at the polls on Election Day. <i>EC 3021</i>
<b>November 5 (E)</b>	<b>ELECTION DAY</b> Polls are open from 7:00 a.m. until 8:00 p.m. <i>EC 1000, 14212</i>
<b>November 7 11:00 a.m. (E+2)</b>	<b>1% Manual Tally - Random Draw for Selection of Precincts</b> Conducted at the county elections office. Precincts selected at random will be included in the 1% manual tally to verify accuracy of vote tabulation machines. <i>EC 15360</i>
<b>November 7 – November 25 (E+2 to E+20)</b>	<b>Canvass of the Vote</b> Official canvass of precinct returns shall commence and be completed during this period. The ROV shall prepare a certified statement of the results and submit it to the governing bodies involved with this election. <i>EC 15301, 15372</i>
<b>December 6</b>	<b>Elected and Appointed Special District Officials Will Take Office</b> At noon on the first Friday in December following this election. <i>EC 10554</i>
<b>December 13</b>	<b>Elected and Appointed School District Officials Will Take Office</b> Governing board members of a school district or community college district take office on the second Friday of December. <i>Ed Code 1007, 1009, 5017</i>

<b>Measure Consolidation</b>	<p><b>Governing Bodies Requesting Measure Consolidation</b> Pursuant to EC 10403, Measure Resolutions are to be submitted to the Board of Supervisors requesting consolidation with this election by E-88; however the ROV has <u>administrative deadlines</u> necessary to meet vendor and print deadlines.</p>
	<p><b>10 Day Public Examination Period</b> During the public examination period, any voter of the jurisdiction may seek a writ of mandate or injunction requesting any or all of the materials to be amended or deleted. <i>EC 9190, 9286, 9295, 9380</i></p>
<b>July 3 (E-125)</b>	<p><b>Consolidation of a Measure with the General District Election (UDEL)</b> Last day to submit a Resolution requesting consolidation to the Board of Supervisors to be calendared for the <b>July 16, 2019 Board of Supervisors meeting</b>. Resolution should include: request for Registrar of Voters to provide services, ballot question (75 word limit), passage requirement, Tax Rate Statement, if applicable, Fiscal Impact Report, if applicable, and specific instruction to include or exclude printing of "Full Text" in the county voter information guide. Resolution should be filed with the Clerk of the Board of Supervisors <b>and</b> the Registrar of Voters. <i>For multi-county districts, file copies of resolution in each county.</i> <i>EC 9140, 9160, 9222, 9280, 9313, 10002, 10403</i></p>
<b>July 16 (E-112)</b>	<p><b>Board of Supervisors Meeting</b> Calendar date for Board of Supervisors to approve consolidation.</p>
<b>July 19 (E-109)</b>	<p><b>Publication</b> For <b>Special District, School District and County Measures</b>, the county elections official shall publish a notice that includes the election date, election location, ballot question, passage requirement and argument and rebuttal deadlines. <span style="float: right;"><i>EC 9163</i></span></p> <p>For <b>Municipal Measures</b>, the city clerk shall publish a public notice including the election date, election location, ballot question, passage requirement and argument and rebuttal deadlines. <i>EC 9205</i></p> <p>For <b>Municipal Measures</b>, the city clerk shall publish a synopsis of the measure at least one time not later than one week before the election in a newspaper of general circulation in the city. <i>EC 12111</i></p>
<b>July 26 (E-102)</b>	<p><b>Filing Deadline: Arguments For and Against</b> (300 Word Limit) Public Examination Period: July 27 – August 5 <span style="float: right;"><i>GC 57146; EC 9162, 9282, 9315</i></span></p>
<b>August 2 (E-95)</b>	<p><b>Filing Deadline: Rebuttal Arguments, if applicable</b> (250 Word Limit) Public Examination Period: August 3 – August 12 <span style="float: right;"><i>EC 9167, 9285, 9286, 9317</i></span></p>
<b>August 2 (E-95)</b>	<p><b>Filing Deadline: Impartial Analysis</b> (500 Word Limit) County Counsel or City Attorney will provide impartial analysis to be printed in the County Voter Information Guide. Public Examination Period: August 3 – August 12 <span style="float: right;"><i>EC 9160, 9280, 9313, 9314, 9500</i></span></p>
<b>November 5</b>	<p><b>Election Day</b> <span style="float: right;"><i>EC 1000</i></span></p>
